No refund shall be made in the event the dog is absent, disqualified, in season, excused by a vet or judge, or bared from the competition by the action of the Show Comm. Or if because of riots, civil disturbances or other act beyond the control of this club, it is impossible to open or complete the show. There will be no refund for duplicate entries or errors made on the entry form. Changes, additions or corrections to entry form must be received in writing prior to close of entries. Entries made by telephone are not acceptable.

Dogs must be ready for judging & will be released if not needed for further judging. Neither the club nor the secretary will be responsible for notifying the exhibitors or their agents for class judging. Judge need not wait for dogs holding up a class.

The GSDC of Beaumont or any of its members assume no responsibility for any loss, damage, or injury sustained by exhibitors, spectators, children, handlers or to any of their dogs or property. It is mandatory that parents, guardians, & handlers control their dogs & children at all times.

Any exhibitor or handler arguing with the show Officials or judge exhibiting unsportsmanlike behavior or violating any AKC rules will be subject to Show Committee jurisdiction.

Dogs which, according to their owners records, have completed the requirements for a championship after the closing of entries for the show, but whose championships are unconfirmed, may be transferred from the regular classes to the Best of Breed competition, provided this transfer is made to the Show Secretary at least 30 minutes before scheduled judging of the show.
